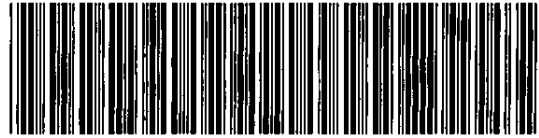



ARTICLE IV – REGISTERED AGENT & OFFICE




