#### A Florida Limited Liability Company

- Name. The name of this limited liability company is Beachwalk Health 1. Care Center, LLC (the "Company"), and it shall be formed as a Florida limited liability. company under Chapter 608, Florida Statutes.
- Duration. The Company shall exist from the date of filing of these Afficle \( \) of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
