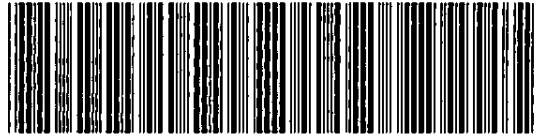

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **WORLD ADVERTISING AND MARKETING OF FLORIDA, LLC** ("Company").

ARTICLE II -- ADDRESS

The street address of the principal office of the company shall be **WORLD ADVERTISING AND MARKETING OF FLORIDA, LLC** at 2504 Victory Palm Drive, Edgewater, FL 32141 and the mailing address is the same.

ARTICLE III OWNERS' ASSOCIATION -- DURATION

The company shall commence its existence on the date the articles of organization were filed by the Florida Department of State. The company's existence shall be perpetual.

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 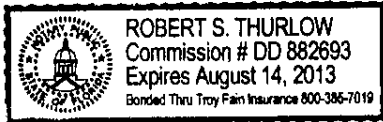

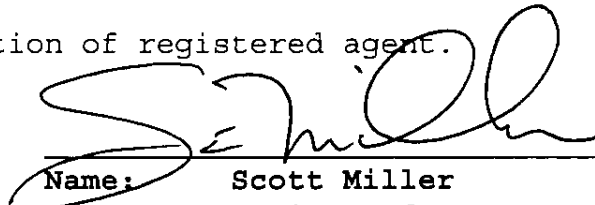
