

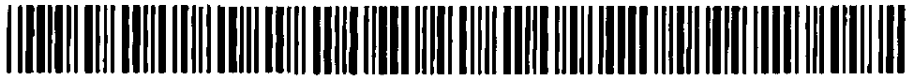

The name of the Limited Liability Company is New Focus Real Estate Services LLC.


ARTICLE II - ADDRESS
