MEMBERSHIP



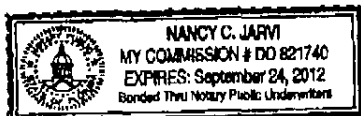
