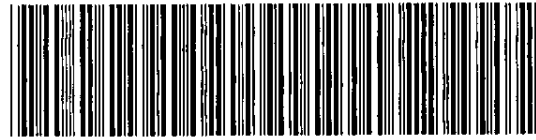



The limited liability company is to be managed by one or more managers and is, therefor, a manager managed company. The initial mangers are: **Isidro Guillama and Bertha Guillama**


