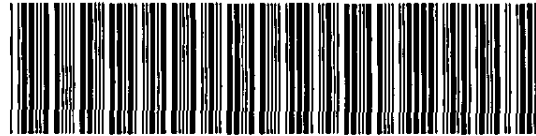

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I**  
Name

The name of the limited liability company (hereinafter referred to as the "Company") is 7870 Baymeadows Way, LLC.

**ARTICLE II**  
Nature of Business and Mailing Address

The Company is organized for the purpose of transacting any or all lawful business. The mailing address and street address of the principal office of the Company is 348 Chicasaw Court, Saint Johns, FL 32259.

Duration

##### Membership Certificates


