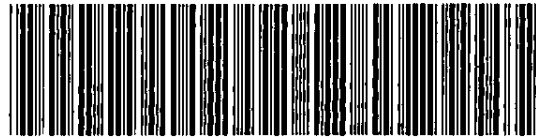



ARTICLES OF ORGANIZATION

FOR

PAULUS LAW, LLC

A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY

The undersigned individual, licensed as an attorney in the State of Florida, acting as member for purposes of forming a professional limited liability company for profit under Chapter 621 and Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization.

**ARTICLE I
NAME**
