**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
SONDAY EQUINE, MOBILE VETERINARY SERVICES, LLC**

The undersigned hereby execute and acknowledge these Amended and Restated Articles of Organization for the purpose of amending the limited liability company initially filed in accordance with the laws of the State of Florida.

**ARTICLE I
NAME**

The name of this company is **Sonday Equine, Mobile Veterinary Services, LLC.**

**ARTICLE II
PERIOD OF DURATION**

This company shall commence as of the date these Articles of Organization are filed with the Department of State of the State of Florida and shall exist perpetually thereafter, unless this company is dissolved pursuant to the terms of the operating agreement for this company or by operation of law.

**ARTICLE III
BUSINESS, OBJECTS OR PURPOSES**

The general nature of the business to be transacted by this company, or the objects or purposes of this company, shall be, in general, to have and exercise all powers conferred by the laws of Florida upon limited liability companies, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.


ARTICLE VIII
