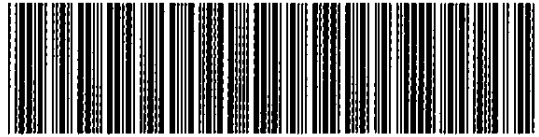

**ARTICLES OF ORGANIZATION
FOR
WOMEN OF DISTINCTION W.O.G.I.C., LLC**

Pursuant to section 608.407 of the Florida Statutes, the undersigned limited liability company executes the following Articles:

**ARTICLE I
Company Name and Address,**

The chosen name of this limited liability company is Women of Distinction W.O.G.I.C., LLC. The mailing address and street address of its principal office is 2635 Solar Rd., Avon Park, FL 33825.

**ARTICLE II
Registered Agent & Address**

The registered agent for this company is Joyce A. Small with a registered office located at 2635 Solar Rd, Avon Park, FL 33825.

**ARTICLE III
Purposes**

Women of Distinction W.O.G.I.C. (hereinafter **WODWOGIC**) is organized to engage in any activity within the purposes for which a limited liability company may be formed under the laws of the State of Florida.

WODWOGIC shall indemnify all of its managers, officers, and agents and all of its former managers, officers, and agents from such liability to the fullest extent permitted by law


ARTICLE VII
Dissolution/Continuation


