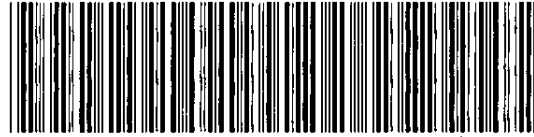

The undersigned organizer, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (the "Act"), does hereby make, acknowledge and file the following Articles of Organization:

Article I
Name

The name of the limited liability company shall be Cutie investment, LLC.
