ARTICLES OF ORGANIZATION
OF
WOOD COMPANY DEVELOPMENT, LLC

The undersigned hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 4161 118th Avenue North, Clearwater, Florida, 33762-5134, and the initial registered agent of the Company at such office shall be Bryan P. Johnson. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

Operating Agreement
