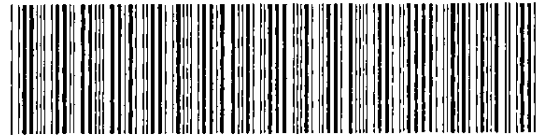

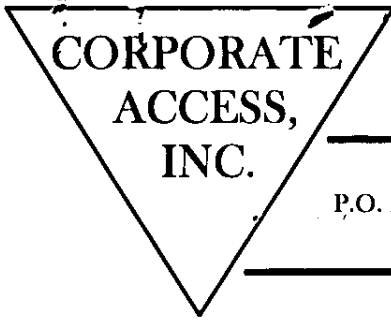

FIRST: These Articles of Amendment amends the Articles of Organization of T & T Roofing & Construction, LLC, a Florida Limited Liability Company ("Company").


SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on November 12, 2009, and the document number of the Company is L09000108617.
