**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be EMU Realty Investment & Development, LLC ("Company"). The principal place of business of the Company in Florida shall be 3010 South Third Street, Jacksonville Beach, Florida 32250. **ARTICLE II
DURATION**

The Company shall commence its existence on the date these Articles of Organization are executed. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE III

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

The Company shall be managed by its members, in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may




contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.




