The Company agrees to indemnify any Member, or any former Member, to the full extent permitted by law.

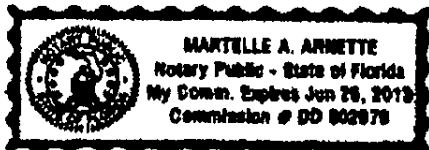
