ARTICLES OF ORGANIZATION

The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or houselfur acquire under any strange, provision of the Articles of Organization or the Operating Agreement of the Company, agreement, vote of Mambers or otherwise.
