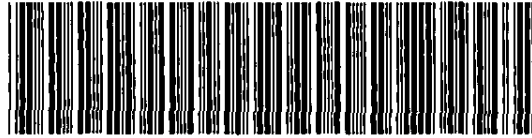

**ARTICLE I.
NAME**

The name of the Limited Liability Company is "FC Patents, LLC" (the "Company").

**ARTICLE II.
ADDRESS**

The mailing address and street address of the principal office of the Company is 3925 SW 13th Street, Ocala, FL 34474.

**ARTICLE III.
DURATION**

The period of duration for the Company shall be perpetual unless the Company is earlier dissolved in accordance with either the provisions of the *Florida Limited Liability Company Act*, Sections 608.401 through 608.514 of the *Florida Statutes Annotated* (the "Act") or the Company's Operating Agreement among the members (the "Operating Agreement").

**ARTICLE IV.
MANAGEMENT**

The Limited Liability Company is to be managed by a manager. The initial Manager is Floyd S. Salser, Jr.

**ARTICLE V.
PURPOSE**

The purpose for which the Company is being organized is to acquire, develop, and thereafter manage, operate, license, protect, and/or resale, patents, intellectual property, trademarks, trade names, copyrights, and other forms of intangible personal property, and to otherwise own, whether in its own capacity or jointly with third parties, property, whether real, tangible personal, or intangible personal, and to transact any other lawful business approved by the members of the Company and for which a limited liability company may be formed under the laws of the State of Florida.

**ARTICLE VI.
MEMBERS' RIGHTS TO CONTINUE BUSINESS**

The right of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any

other event which terminates the continued membership of a member in the Company shall be upon the consent of all of the remaining members in accordance with the terms and conditions of the Operating Agreement to continue the business of the Company, provided that there is at least one (1) remaining member.

The Company reserves the right to amend, alter, change or repeal any provision contained in these Articles of Organization, in the manner now or hereafter prescribed by the Act.
