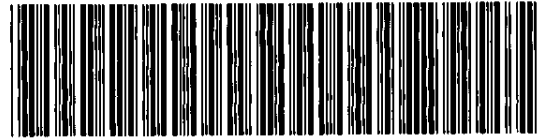

The name of the Limited Liability Company shall be: **3 WICE DISTRIBUTION, LLC.**


