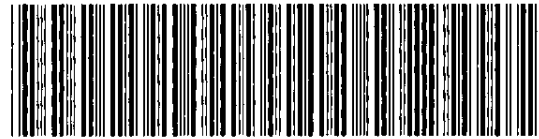

The name of the Limited Liability Company is CD GROUP IV, LLC (the "Company").


**ARTICLE II - Address**


