

ARTICLES OF ORGANIZATION

OF

PACEMAKER WAHOO, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of organization.

ARTICLE I - NAME

The name of the limited liability company shall be PACEMAKER WAHOO, LLC.

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company are 95 Fiesta Way, Ft. Lauderdale, Florida 33301.

ARTICLE III - DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

<u>ARTICLE IV - REGISTERED OFFICE AND AGENT</u>

ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

The company shall be managed by a manager in accordance with regulations adopted by the members for the management of the business and affairs of the company.


