**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
TECNITRAXS, LLC.
a Florida Limited Liability Company
(the "Company")**

FIRST: The date of Filing of the Articles of Organization was 11/17/2009.

SECOND: Article II of the Articles of Organization of the Company is hereby amended to read in its entirety as follows:

**ARTICLE II
GENERAL NATURE OF BUSINESS**

The Limited Liability Company may engage in the import and export, sale and distribution of constructions and industrial and agricultural equipment, machinery and parts, tools and instruments, heavy equipment, manufacturing equipment, general machinery and vehicles. Notwithstanding the foregoing, the Company may also engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The Company shall have the power to conduct its business, locate offices, and to do all things necessary to carry out its business and affairs within the State of Florida or outside this state or country.

THIRD: The foregoing amendment to the Articles of Organization of the Company will be adopted effective as of the date of filing with the Division of Corporation of the Florida Department of State.
