OF

The undersigned, acting as the organizer of LHT PAIN RELIEF, LLC under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I - Name:

The name of the limited liability company is LHT PAIN RELIEF, LLC, "Company").
