**ARTICLE III - DURATION**

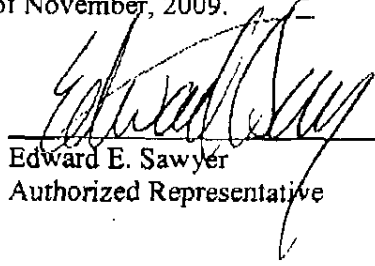
