ARTICLE I





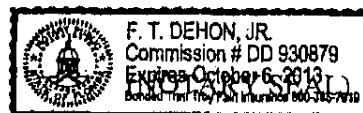
