**ARTICLE I - Name:**

The name of the limited liability company is POTS by Tracy, LLC (the "Company").

**ARTICLE II - Address:**

The mailing address and street address of the principal office of the limited liability company is 2867 Stonewall Place, Suite 101, Sanford, Florida 32773.

**ARTICLE III - Duration:**


