**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF  
675 CYPRESS WAY EAST, LLC**

The undersigned, for the purpose of amending the Articles of Organization of **675 CYPRESS WAY EAST, LLC**, a Florida limited liability company ("Company"), hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 605.0202, Florida Statutes.

**FIRST:** The Articles of Organization of **675 CYPRESS WAY EAST, LLC**, were filed with the Florida Department of State on November 23, 2009, and were assigned Document Number L09000112473. Stephen C. Roberts was therein named as the "Managing Member" of the Company. The Company was thereby designated as a "member managed" Florida limited liability company.

**SECOND:** In order to comply with requirements of Chapter 605 of the Florida Statutes which has previously been amended to no longer permit Florida limited liability companies to designate a "Managing Member" to manage such companies, the Company desires to convert the Company from a "member managed" Florida limited liability company to a "manager managed" Florida limited liability company, and to designate the Manager of the Company as provided below.

**THIRD:** The following amendment to the Articles of Organization was adopted by **675 CYPRESS WAY EAST, LLC**:

Article V is hereby deleted and replaced as follows:

**ARTICLE V**

The Company shall be managed by a manager, and accordingly, the Company shall be deemed to be a "manager managed" Florida limited liability company as provided under Chapter 605 of the Florida Statutes. 
