### ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF 675 CYPRESS WAY EAST, LLC

The undersigned, for the purpose of amending the Articles of Organization of 675 CYPRESS WAY EAST, LLC, a Florida limited liability company ("Company"), hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 605.0202, Florida Statutes.

FIRST: The Articles of Organization of 675 CYPRESS WAY EAST, LLC, were filed with the Florida Department of State on November 23, 2009, and were assigned Document Number L09000112473. Stephen C. Roberts was therein named as the "Managing Member" of the Company. The Company was thereby designated as a "member managed" Florida limited liability company.
