# ARTICLES OF ORGANIZATION OF YANKEE TARA, LLC

## ARTICLE I Name and Principal Place of Business

The name of this limited liability company is YANKEE TARA, LLC; the physical address of its principal office is 2105 Dillon Court, Valrico, Florida 33596, and its mailing address is the same.

## ARTICLE II Purposes

The powers of this limited liability company shall be exercised by or under the authority of, and the business and affairs shall be managed under, the direction of the members of this limited liability company.

This Article may be amended from time to time in accordance with the regulations of this limited liability company by majority vote of the members.

## ARTICLE IV

Additional contributions will be made as required and as determined by unanimous consent of the members and will be made in such proportionate amounts as to maintain the capital accounts in the same proportion as arose from the original contribution set forth above.

## ARTICLE VII Profits and Losses

- A. **Profits.** After payment of the expenses of this limited liability company, each member shall be entitled to a distributive share of the profits of this limited liability company in accordance with an agreed upon formula or, in the absence of such formula, in proportion to each members' then outstanding contributed and not returned capital.
