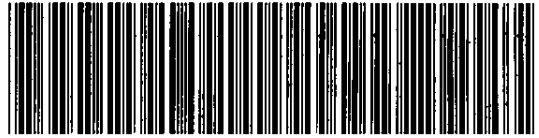

#### **ARTICLE VIII - Registered Agent:**

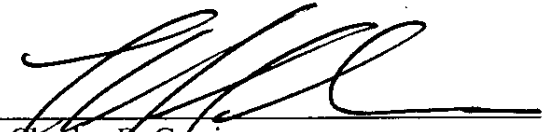

Pursuant to F.S. §608.4235 no member of the Company shall be an agent of the Company solely by virtue of being a member.

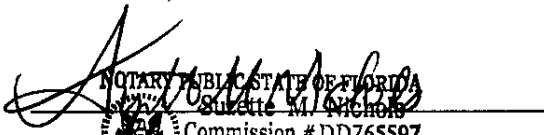
