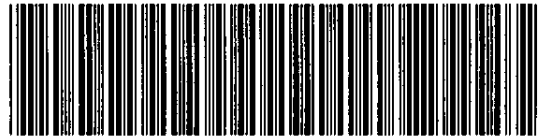

**ARTICLE I**

The name of the Limited Liability Company is: HR Resources, LLC (hereinafter referred to as the "Company"). The Articles of Organization of the Company were filed on November 24, 2009 and assigned Florida document number L09000113104.

**ARTICLE II**

The Articles of Organization of the Company contain and incorrect statement. Article V. of the Articles of Organization of the Company currently states:

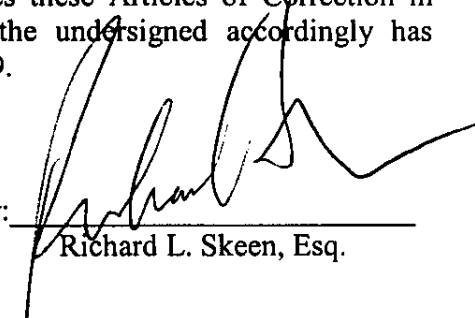
The corrected Article V. of the Articles of Organization should read as follows:
