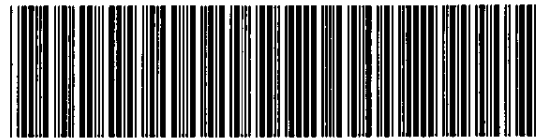

**ARTICLES OF ORGANIZATION**  
**OF**  
**ATOCHA/MARGARITA EXPEDITION - 2010, LLC**

The Articles of Organization following are adopted for the purpose of organizing a Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

**ARTICLE I**

*Name and Address of Company*

The name of the limited liability company (hereinafter referred to as the "Company") is Atocha/Margarita Expedition - 2010, LLC. The Company's street address and mailing address is 200 Greene Street, Key West FL 33040.

**ARTICLE II**

*Commencement and Duration of Company*

The Company shall exist from the date of filing these Articles with the Florida Department of State until the occurrence of any of the events specified in Section 608.441, unless continued by the unanimous consent of all of the remaining members.

**ARTICLE III**

*Management*

The Company is to be managed by a manager or managers and the name and address of the initial manager is Crystals Recovery, Inc., Managing Director, 200 Greene Street, Key West FL 33040.

**ARTICLE IV**

*Admission of Additional Members*

Additional members may be admitted to the Company but only if all the current members or their attorney-in-fact agree to the admission of the additional members and to the terms of such admission.

### *Termination of Membership*

If a member of the Company dies, retires, resigns, is expelled, declared insane, becomes bankrupt, is dissolved or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members (or their attorney-in-fact) may, by unanimous written agreement, continue the business of the Company.

## ARTICLE VI

### *Registered Agent and Office*

## ARTICLE VII

### *Operating Agreement and Regulations*




