



AGREEMENT AND PLAN OF DISSOLUTION
OF
TRO Holdings, LLC

This Agreement and Plan of Dissolution is made effective this 20 day of DECEMBER, 2016 by PENN GROUP ENTERPRISES S. de R.L., a Panamanian Company, as Sole Member of and on behalf of TRO Holdings, LLC (the "Company").

BACKGROUND

PENN GROUP ENTERPRISES S. de R.L., a Panamanian Company (the "Member") is the only Member of the Company. The Member holds a One Hundred Percent (100%) interest in the Company. The Member and the Company wish to arrange for the dissolution of the Company.

AGREEMENT AND PLAN OF DISSOLUTION

1. Effective as of the date when the Articles of Dissolution are filed with the Florida Department of State, the Company is dissolved and exists thereafter solely for the purpose of dissolving and distributing its assets in accordance with s. 605.0709, except for the purpose of lawsuits, other proceedings, and appropriate action as provided in Chapter 605 of the Florida Statutes.
