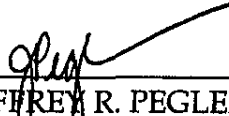
ARTICLE V -- GOVERNED BY OPERATING AGREEMENT

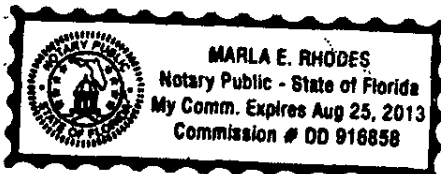
