ARTICLE I
NAME

The name of the Limited Liability Company (the "Company") is NJGV Holdings, LLC.

ARTICLE II

The Company is to be managed by one or more managers and is, therefore, a manager-managed company.

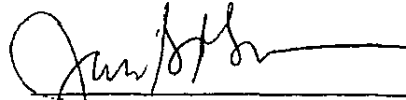
ARTICLE V

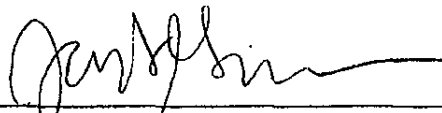
