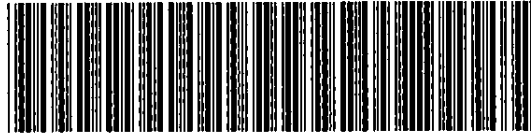

The name of the Company is Third City Landowners, LLC.




