**ARTICLE I**

**NAME AND ADDRESS**

The name of the limited liability company shall be PALM VALLEY ENTERPRISES, LLC (the "*Company*"). The mailing address and the street address of the principal office in Florida shall be 153 Roscoe Boulevard North, Ponte Vedra Beach, Florida 32082.

**ARTICLE II**

**PURPOSES AND POWERS**
