**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF

Pursuant to Section 608.411 of the Florida Limited Liability Act, the undersigned, on behalf and in the name of AMERICAN INSTITUTE OF PROFESSIONAL EDUCATION, LLC, a Florida limited liability company (the "Company"), adopts these Articles of Amendment.

1. The name of the Company is American Institute of Professional Education, LLC.
2. The Articles of Organization were filed on December 3, 2009, and assigned a document number L09000115206.
3. The Articles of Organization of this Company are amended by modifying and amending Article I in its entirety and replacing it with the following:

**"ARTICLE I
