
ARTICLE V - MEMBERSHIP

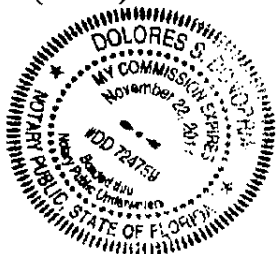




