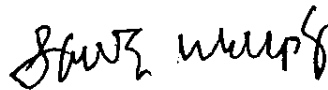

ARTICLES OF ORGANIZATION

OF

ABOUJAOUDE, LLC

The undersigned (Member), for the purpose of forming a single-member limited liability company under Chapter 608 of the Florida Statutes ("the Act"), hereby sets forth the following:

ARTICLE I- NAME

The name of the limited liability company is ABOUJAOUDE, LLC ("the Company").

ARTICLE II - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. 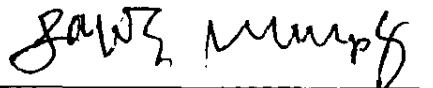

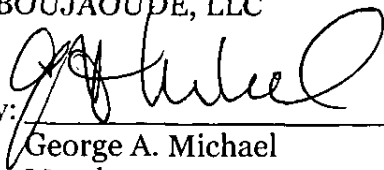
