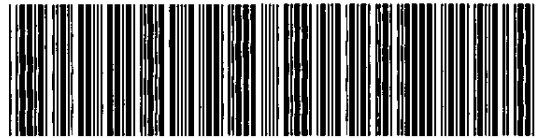

A Florida Limited Liability Company

**ARTICLE I - Name**

The name of the Limited Liability Company is: Family Psychiatric Services, LLC.

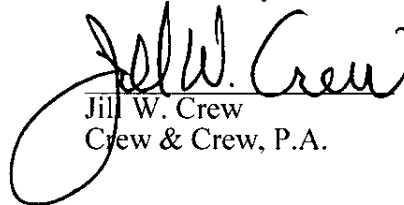
