The name of the Company is Franklin Boulevard Development, LLC.

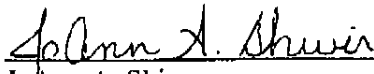

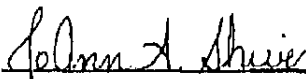
