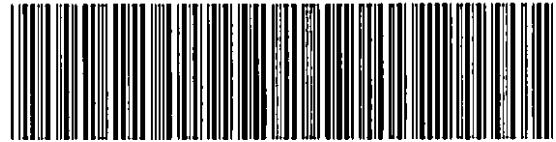

This Company's Articles of Organization were filed on December 9, 2009, and subsequently amended to change the name of the company on December 30, 2009; Document Number **L09000117188**.

ARTICLE I - NAME

ARTICLE VIII - AMENDMENT

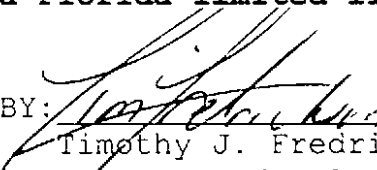
