The undersigned, MUMMIES OF THE WORLD TOURING COMPANY, LLC (the "Company"), desiring to form a limited liability company under the Florida Limited Liability Company Act, codified as Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization of such Company.

ARTICLE I

NAME

The name of the limited liability company is MUMMIES OF THE WORLD TOURING COMPANY, LLC.

ARTICLE II

MAILING AND STREET ADDRESS

The Company is to be managed by its Managers. The entity that will serve as Manager until the first annual meeting of Members or until its successor is elected and qualified is:


