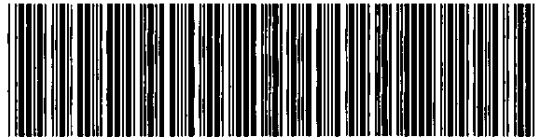

The undersigned hereby executes these Articles of Organization (“**Articles**”) for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

**ARTICLE I**

**Name**

The name of this limited liability company (the “**Company**”) shall be:

**ARTICLE II**

**Principal Office and Mailing Address**
