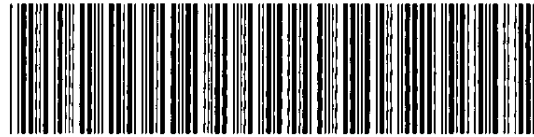

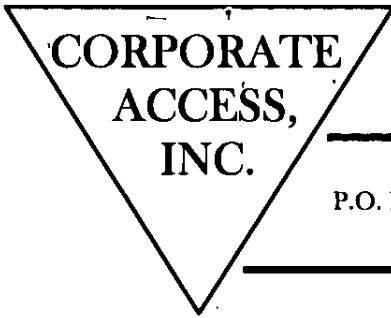

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the Limited Liability Company ("Company") shall be:

## **ARTICLE VIII. INITIAL REGISTERED OFFICE AND REGISTERED AGENT**




