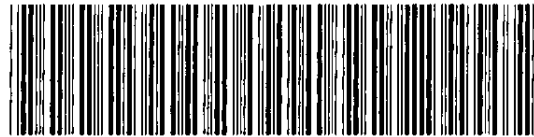

**ARTICLE I  
NAME**

The name of this professional limited liability company (the "Company") shall be **SHERI LUND KERNEY, P. L.** and its mailing address is 1420 E. Concord St., Orlando, FL 32803, and its principal place of business is 1420 E. Concord St., Orlando, FL 32803.

**ARTICLE II  
COMMENCEMENT OF EXISTENCE**

This Company shall commence existence on the date these articles of organization are filed with the Florida Department of State and shall have perpetual existence unless sooner dissolved in accordance with the Operating Agreement of the Company or according to law.

**ARTICLE III  
GENERAL PURPOSE; GENERAL POWERS**

The general nature of the business to be transacted by this limited liability company shall be:

- A. To engage in every phase and aspect of the business of rendering the same professional services to the public that an Attorney at Law, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees, and agents of the Company who are duly licensed under the laws of the State of Florida to practice.
- B. To invest the funds of this Company in real estate, mortgages, stocks, bonds, or any other type of investments and to own real and personal property necessary for the rendering of such services.
- C. To do anything necessary and proper for the accomplishment or furtherance of any

of the purposes or objects of this Company enumerated in these Articles of Organization, or any amendment thereof, necessary or incidental to the protection and benefit of this Company; and in general, either alone or in association with other companies, firms or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment or furtherance of such purposes or objects of this Company.

- D. It is intended that this professional limited liability company may conduct and transact any business lawfully authorized and not prohibited by Chapter 621, Florida Statutes, as the same may be amended from time to time.

#### **ARTICLE IV**

#### **INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this Company shall be located at 1420 E. Concord St., Orlando, FL 32803, and the initial registered agent of this Company at that address shall be SHERI LUND KERNEY. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment of these articles of organization.

#### **ARTICLE V**

#### **MANAGEMENT**

The Company will be managed by a Manager or Managers as set forth in the Operating Agreement adopted by the Company. The Managers have sole authority to manage the Company and are authorized to make any contracts, enter into any transactions, and make and obtain any commitments on behalf of the Company to conduct or further the Company's business. Except as authorized by the Managers, no Member is an agent of the Company or has the authority to make any contracts, enter into any transactions, or make any commitments on behalf of the Company.

#### **ARTICLE VI**

#### **OPERATING AGREEMENT**

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Manager.

**ARTICLE VII**  
**ADMISSION OF NEW MEMBERS**

Additional Members may be admitted from time to time on such terms and conditions as determined by the Manager. No current Member has any preemptive rights.

**ARTICLE VIII**  
**DEATH, RETIREMENT, RESIGNATION, BANKRUPTCY, EXPULSION,**  
**DISSOLUTION OF MEMBER**

In the event of the death, retirement, resignation, bankruptcy, expulsion or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the Manager may continue the business of the Company without a vote of the Members so long as there is at least one remaining Member of the Company.

**ARTICLE IX**  
**AMENDMENT**

The right to amend or repeal any provisions contained in these articles of organization, or any amendment hereto, is conferred upon the Manager.

**ARTICLE X**  
**HEADINGS AND CAPTIONS**

The headings or captions of these various articles of organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
