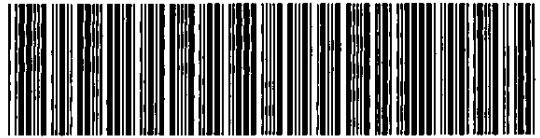

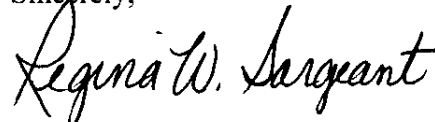

ARTICLE I - Company Name: The name of the Company is: ISOBEL MCGRATH LLC.

ARTICLE V - Management: The Company shall have a manager.

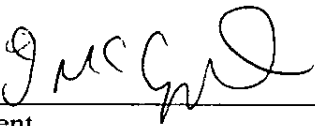

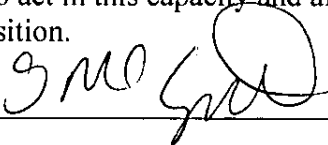
