

**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I**  
**NAME OF COMPANY**

The name of the limited liability company is Smartola, LLC (the "Company").

**ARTICLE II**  
**PERIOD OF DURATION**

The Company shall terminate on December 31, 2109.
