- FIRST:** The name and address of this Company is **ALPHA CONSTRUCTION & MECHANICAL SERVICES LLC**, 11469 Southeast 82nd Court Road, Ocala, Florida 34481.
- SECOND:** The Articles of Organization were filed on December 14, 2009, effective January 4, 2010 and assigned document number L09000118381.

- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
