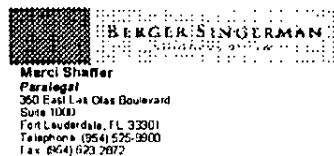

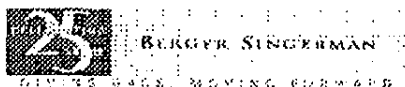

Article IV be added to the Company's Articles of Organization to read as follows:

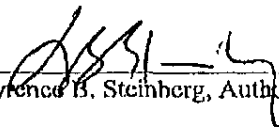
